IN RE: JUDICIAL EMERGENCY TERM CALENDAR CHANGE

ORDER

The Supreme Court of Georgia and Northern Judicial Circuit have issued extended Judicial Emergency Orders running through May 13, 2020. In an effort to handle the essential matters with judicial economy considering health concerns and the need to minimize routine contact with the public, the Superior Court Judges of the circuit publish this new calendar for portions of April and May 2020. See the attached calendar. This calendar will replace the individual term calendars previously published by the three judges until May 18, 2020.

The Clerks are instructed to schedule any essential civil and/or criminal matter on the next available date for their particular county. A Duty Judge will preside over all matters scheduled on that date regardless of assignment unless there is particular cause to defer the issue to the assigned judge.

The judges and/or their staff will notify any parties with previously scheduled non-essential hearings that those matters will be continued to a later date. Arrangements for rescheduling those particular matters should be presented to the assigned judge.
