ALL PARTIES MUST BE PRESENT OCTOBER 15, 2026 at 9:30 A.M. FOR THE FINAL TRIAL CALENDAR REVIEW. Any pending Motion(s) or Plea(s) not scheduled and brought for hearing on said date, absent good cause shown, shall be considered abandoned. All parties shall be ready to proceed to trial in the Superior Court of Oglethorpe County the week beginning October 19, 2026.

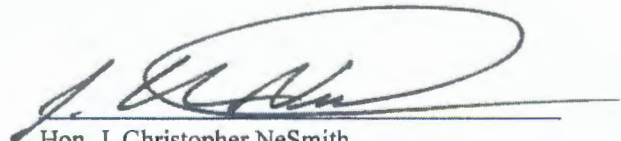

All plea offers shall be made prior to October 15, 2026.
