ORDER SETTING TRIAL CALENDAR

This Order is entered in regard to the criminal jury trial week scheduled for September 29, 2025 through October 3, 2025.

The cases set forth on Exhibit "A" constitute the trial calendar for the criminal jury trial week scheduled for September 29, 2025 - October 3, 2025.

The first five (5) cases on the Trial Calendar shall appear on September 29, 2025 at 9:00 o'clock A.M. ready for trial. All other cases shall be on "next day" call. In the event any of the first five (5) cases should resolve prior to September 29, 2025 counsel for subsequent cases shall be notified of such and shall then appear on September 29, 2025 at 9:00 o'clock A.M. ready for trial.

The District Attorney shall advise the Court of any cases not on Exhibit "A" that are jail cases or that are the subject of statutory speedy trial demands. If any such cases are not on Exhibit "A" the Court will file and publish an Amended Order which includes any such cases.

Prior to the week of trial, the Court will be in session on September 5, 2025 at 9:30 o'clock A.M., and on September 26, 2025 at 9:30 o'clock A.M. for the purpose of negotiated or blind pleas, and for the purpose of hearing pending Motions. The Court has set aside the entire day of September 26, 2025 for counsel to resolve cases on the trial calendar. All counsel are advised that any case on the trial calendar for which the Court has not been advised has been resolved when Court adjourns for the day on September 26, 2025, will thereafter only be


resolved by nolle prosequi, blind plea or trial, and the Court will not thereafter accept any negotiated plea for any such case, during the trial week or at any subsequent time thereafter.

It shall be the responsibility and obligation of the moving party to cause a Rule Nisi to issue for the hearing of any pending Motion(s) for either of the two (2) dates set forth above. Any pending Motions not scheduled and brought for hearing on one of said dates, absent good cause shown, shall be considered abandoned.

No continuance or removal from the calendar shall be granted except for good cause. Further, any request for removal or continuance shall be brought before the Court for hearing on one of the two (2) dates available for pleas and motions.

Counsel shall **strictly** and **timely** comply with Rule 17.1(B) of the Uniform Rules for Superior Courts in regard to any conflicts for the week of trial.
