AND IT IS FURTHER ORDERED, that should the Court receive conflict notices from counsel, the Court will consult with the Courts in conflict and counsel will be notified in such event if the Court(s) in conflict agree for counsel to appear in Oglethorpe Superior Court on the date and at the time designated. In this regard, counsel shall strictly comply with Rule 17.1(B) of the

Uniform Rules for Superior Courts.

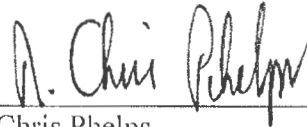
