As provided in this Court's Order entered on April 18, 2023, this constitutes the final jury trial calendar for the trial week of July 10 - July 14, 2023.



No continuance or removal from the Trial Calendar shall be granted except for good cause, and any such request shall be submitted to the Court in writing, with the reasons for such request being specifically set forth therein. A copy of any such request shall be served upon opposing counsel, and opposing counsel shall have twenty-four (24) hours to submit a response. Thereafter, the Court shall either grant or deny the request.

Should the Court receive conflict notices from counsel, the Court will consult with the Courts in conflict and counsel will be notified in such event if the Court(s) in conflict agree for counsel to appear in Oglethorpe Superior Court on the date and at the time designated. In this regard, counsel shall strictly comply with Rule 17.1(B) of the Uniform Rules for Superior Courts.
