IT IS HEREBY ORDERED THAT the series of cases set forth on the attachment hereto and labeled as "EXHIBIT A", shall constitute the calendar for January 28, 2025, at 9:30 a.m., and the Trial Week of February 10 – February 14, 2025, at 9:00 a.m., and the backup Trial Week of March 10 – March 14, 2025, at 9:00 a.m., in the sequence listed.

CRIMINAL PLEA & TRIAL MOTIONS

IT IS FURTHER ORDERED THAT the Court shall conduct a Criminal Plea & Motion Day on January 28, 2025, at 9:30 a.m., in the courtroom of the Oglethorpe County Courthouse, Lexington, Georgia. All parties are directed to appear on this date. The State and the Defense Counsel shall bring forth all pleas and pre-trial motions on said hearing day for consideration by the Court. If a Defendant has a pending Pre-trial Motion, the Defense Counsel shall schedule a time on said Criminal Plea & Motion date with Judge Harvey Wasserman's Judicial Assistant, Karen Westbrook via email (kwestbrook@franklincountyga.gov). A time will be provided to the Defense Counsel and the State by Ms. Westbrook once a courtesy copy of all Motions has been forwarded to the Court. The State shall coordinate the appearance and participation of any incarcerated defendant(s) with the personnel of the Georgia Department of Corrections and/or the Oglethorpe County Jail via Webex.

ALL PAPERWORK SHALL BE COMPLETED PRIOR TO THE DEFENDANT'S SCHEDULED APPEARANCE TIME.

IT IS FURTHER ORDERED THAT the first twenty cases remaining on the Trial Calendar at the conclusion of the hearings on January 28, 2025, shall report for jury selection on Monday, February 10, 2025, at 9:00 a.m. and shall remain until otherwise excused by the Court. If your case is not called on February 10, 2025, all parties shall remain on call for the remainder of the trial weeks or until excused by the Court.

Any agreed upon resolution of a case on the Jury Trial Calendar subsequent to the date of this Order shall be immediately reported to the Court by the District Attorney by emailing Judge Wasserman's Judicial Assistant. The Court will, upon receiving such notice, communicate to counsel on the case(s) next in priority on the Trial Calendar, and inform said counsel that its position has advanced and, counsel and defendant shall appear on the date and the time designated by the Court, ready for Trial.

No leave of absence shall be approved throughout the duration of this Jury Trial Calendar, except for emergency circumstances. No continuance or removal from the Jury Trial Calendar shall be granted except for good cause, and such request shall be submitted to the Court in writing, with the reasons for such request being specifically set forth therein. Should the Court receive conflict notices from counsel, the Court will consult with the court(s) in conflict and counsel will be notified in such event if the court(s) in conflict agree for counsel to appear before the Oglethorpe County Superior Court on the date and time designated.

Copies of this Order shall be sent to the State, Public Defender's Office, and all private defense attorneys via email by the Court, and to the Defendant and Bondsmen via U.S. Mail by the court, on the date listed below.
